# CONSOLIDATED AND AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE VILLAGES OF CARMEL

THE STATE OF TEXAS §

COUNTY OF DENTON §

KNOW ALL MEN BY THESE PRESENTS:

THIS CONSOLIDATED AND AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE VILLAGES OF CARMEL (this "Declaration") is made and entered into this a day of May, 2019, by ASTRA CARMEL, LLC ("Master Declarant") as the successor "Declarant" to HOLIGAN LAND DEVELOPMENT, LTD., a Texas limited partnership ("Holigan") and HMH LIFESTYLES, L.P., a Texas limited partnership ("Phase 5 Declarant") as the successor "Declarant" to DW CARMEL, LLC, a Texas limited liability company.

#### WITNESSETH:

WHEREAS, Holigan filed for record that certain Master Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel, recorded as Instrument Number 2006-101525 in the Official Records of Denton County, Texas (the "Initial Master Declaration"), as amended and/or supplemented by that certain First Supplemental Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel (The Villages of Carmel Phase III), recorded as Instrument Number 2006-150332 in the Official Records of Denton County, Texas (the "First Supplemental Master Declaration"), as amended by that certain Amendment to the First Supplemental Declaration of Covenants, Conditions, and Restrictions for The Villages of Carmel, recorded as Instrument Number 2007-95154 in the Official Records of Denton County, Texas (the "First Amendment to First Supplemental Master Declaration"); that certain Second Supplemental Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel, recorded as Instrument Number 2007-54404 in the Official Records of Denton County, Texas (the "Second Supplemental Master Declaration"); that certain Third Supplemental Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel, recorded as Instrument Number 2012-138510 in the Official Records of Denton County, Texas (the "Third Supplemental Master Declaration"); that certain Fourth Supplemental Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel, recorded as Instrument Number 2014-56338 in the Official Records of Denton County, Texas (the "Fourth Supplemental Master Declaration"); that certain Fifth Supplemental Declaration of Covenants, Conditions and Restrictions for The Villages of Carmel, recorded as Instrument Number 2014-120547 in the Official Records of Denton County, Texas (the "Fifth Supplemental Master Declaration"); that certain Sixth Supplemental Declaration of Covenants, Conditions, and Restrictions for The Villages of Carmel, recorded as Instrument Number 2018-116663 in the Official Records of Denton County, Texas

(the "Sixth Supplemental Master Declaration"); that certain Seventh Supplemental Declaration of Covenants, Conditions, and Restrictions for The Villages of Carmel, recorded as Instrument Number 2019-0426000680 in the Official Records of Denton County, Texas (the "Seventh Supplemental Master Declaration, First Supplemental Master Declaration, First Supplemental Master Declaration, Second Supplemental Master Declaration, Third Supplemental Master Declaration, Fourth Supplemental Master Declaration, Fifth Supplemental Master Declaration, Sixth Supplemental Master Declaration and Seventh Supplemental Master Declaration are hereinafter collectively referred to as the "Master Declaration").

WHEREAS, The Villages of Carmel Homeowners' Association, Inc., a Texas nonprofit corporation (the "Master Association") is a Texas nonprofit corporation formed to serve as the homeowners association for the planned unit development known as The Villages of Carmel (the "Villages of Carmel Master Subdivision") as established by the Initial Master Declaration; and

WHEREAS, the DW Carmel, LLC filed for record that certain Declaration of Covenants, Conditions & Restrictions for Villages of Carmel Phase 5 on or about November 1, 2017, as Instrument No. 2017I 101000439 of the Real Property Records of Denton County, Texas (the "Phase 5 Declaration"), as amended and/or supplemented from time to time; and

WHEREAS, the 2017 Villages of Carmel Homeowners Association, Inc., a Texas nonprofit corporation (the "Phase 5 Association") was a Texas nonprofit corporation formed to serve as the homeowners association for the planned unit development known as Villages of Carmel Phase 5 (the "Phase 5 Subdivision") as established by the Phase 5 Declaration; and

WHEREAS, Section 10.001(a) of the Texas Business Organizations Code authorizes a domestic entity to effect a merger by complying with the applicable provisions of the Texas Business Organizations Code; and

WHEREAS, the members of the Master Association and the Phase 5 Association have each adopted the Plan of Merger and approved the merger (the "Merger") of the two associations in accordance with the Texas Business Organizations Code, with the Master Association being the surviving corporation; and

WHEREAS, in accordance the Plan of Merger, the Master Declaration and the Phase 5 Declaration are to be amended and consolidated into one instrument which will be recorded against the Villages of Carmel Master Subdivision and the Phase 5 Subdivision: and

WHEREAS, pursuant to <u>Section 12.2</u> of the Master Declaration, the Master Declarant, in its sole discretion and without a vote or the consent of any Owners or other parties, has the right to amend the Master Declaration for any purpose; and

WHEREAS, pursuant to <u>Section 16.2</u> of the Phase 5 Declaration, the Phase 5 Declarant, so long as the Phase 5 Declarant owns at least one (1) Lot (as defined therein), may unilaterally amend, supplement, restate or revoke the Phase 5 Declaration; and

WHEREAS, the Master Declarant and the Phase 5 Declarant desire to amend their respective Declarations and consolidate them under the same set of covenants, conditions, restrictions, easements, liens and charges.

NOW, THEREFORE, this Declaration does hereby amend, replace and supersede the Master Declaration and the Phase 5 Declaration except as provided herein, and from and after the date of the recording of this Declaration in the Deed Records of Denton County, Texas (the "Effective Date"), all of the Property set forth on Exhibit "A" attached hereto and incorporated herein by reference, shall be owned, held, transferred, leased, sold, conveyed and occupied subject to the covenants, conditions, restrictions, easements, liens and charges hereinafter set forth.

# ARTICLE I – MASTER DECLARATION

1.1 The Master Declaration, including all Exhibits, supplements and amendments thereto, is hereby incorporated herein as if set forth in its entirety. The terms and provisions of this Declaration (after incorporating the terms and provisions of the Master Declaration and all Exhibits, supplements and amendments thereto) shall be binding on and covenants running with all property in the Villages of Carmel Master Subdivision and Phase 5 Subdivision.

# ARTICLE II – PHASE 5 DECLARATION

- 2.1 The Phase 5 Declaration, including any and all Exhibits, supplements and amendments thereto, is hereby amended by deleting the Phase 5 Declaration in its entirety and replacing it with this Declaration except as follows:
  - (a) Section 3.2 of the Phase 5 Declaration entitled "EASEMENT FOR PERIMETER SCREENING FENCE" shall be incorporated herein as if set forth in its entirety.
  - (b) Section 7.3 of the Phase 5 Declaration entitled "LEASE RESTRICTIONS" shall be incorporated herein as if set forth in its entirety.


